



Dear Current and Potential Sea Palms Members,

Good things are happening at Sea Palms!

As we approach the end of 2019, please accept our sincere thanks for your continued support of Sea Palms Resort. With 2020 on the horizon and the new changes and improvements in full force, we look forward to continuing our relationship with you as a supporting member of the club.

The 2020 Membership Offerings reflect changes designed to streamline membership categories. When preparing for your membership renewal for 2020, please review all categories to ensure you choose what best fits your needs. All current club amenities including Golf, Driving Range, Tennis, Fitness, Pools and Food and Beverage will be available to memberships for 2020!

The following memberships have been established for 2020:

- The **Full Membership** category is inclusive of all club amenities to include green fees (**Cart Fees Apply**). There will be a separate “cart plan” available for purchase for full members. Discounts for Food and Beverage and Golf Shop merchandise will be 20% respectively.
- The **Corporate Membership** will coincide with the full membership category and will be sold on a limited basis. The corporate category is designed to include a business owner and two additional employees to fulfill the membership. Employees will be asked to provide W-2 documentation to ensure proper protocol is in order. This category can be paid in full or in two installments (January and July) and cannot be pro-rated or used as a short-term membership. Food and Beverage minimums in the corporate category are applied per individual, so each member is responsible for a monthly minimum.
- The **Social Membership** category is inclusive of all club amenities, apart from golf. Social members are eligible for **10% off the daily public golf rate**. Discounts for Food and Beverage and Golf Shop merchandise will be 20% respectively.
- The **National Membership** (Must reside outside of Glynn County more than 6 months yearly.) **This category is inclusive of all club amenities and will be paid in full as a one-time fee.** Member cart fees apply at the rate of \$25/\$16 for eighteen/nine holes. Discounts for Food and Beverage and Golf Shop merchandise will be 20% respectively.
- The **Summer Pool Membership** will be offered from May 7th – September 7th. **This category will be paid in full as a one-time fee and will not be pro-rated.** Discounts for Food and Beverage and Golf Shop merchandise will be 20% respectively.
- Sea Palms will offer **Seasonal** Memberships in the **Full** category at a three- or six-month terms only. Short term memberships will incur a 10% surcharge to the current monthly dues. Seasonal memberships can only be obtained one time per calendar year.

- An approved credit card or valid bank account will be required for all membership accounts. Members will receive a statement for dues and monthly incidentals that will be drafted on the 15th day of each month. **Additionally, all monthly dues will have a 3% monthly processing fee for the 2020 year.**

- **Membership discounts are only applied with a valid membership card present at the time of service.**

**Full, Social, and Summer Pool** memberships will require a Food & Beverage Minimum. Minimums will be \$75 per month for all family memberships, \$50 per month for all single memberships and \$75 per month for all Summer Pool Memberships. **National memberships** are excluded from the food & beverage monthly minimum. All accounts are tracked on a monthly basis for reaching the minimum requirement. Food & Beverage attritions will be charged quarterly.


Once you have signed the membership contract you will be financially responsible for all monthly dues and any incurred charges. Should you choose to terminate your membership, you will be subject to any and all initiation and rejoining fees. Exceptions will be considered when the member provides proof of hardship such as divorce, moving to a different county, or medical ailment. **Members will get one medical or personal “leave of absence” per 24 months without paying the current Initiation Fee when re-joining the club. Additionally, members are allowed to change membership categories once per 24 months.**

All memberships will go before the membership committee for approval. Once approved or denied the prospective member will be notified via email. Approvals will be executed on the 1st and 15th day of each month and may take up to 15 days to complete.
